# What is Spectrum of Care Question

- 1. All the things a veterinarian should know how to do
- 2. The ability to provide care across a spectrum of species
- 3. The concept that veterinary care exists along a continuum
- 4. All types of practice outside of specialty medicine

# What is Spectrum of Care In the literature

#### The term SOC has been defined as:

"the wide spectrum of diagnostic and treatment options [that veterinarians] can provide for their patients." (Stull et al., 2018, p. 1386)

#### Practicing across the spectrum entails:

"providing a continuum of acceptable care that...

- Considers available evidence-based medicine
- Is responsive to client expectations and financial limitations" (Fingland et al., 2021, p. 464)
- Integrates "a broad range of client factors that affect care." (Englar & Dial, 2022, p.6)



# What is Spectrum of Care A unifying concept

**Contextualizing Care** – Adapting research evidence to patient life context

**Incremental Care** – Stepwise diagnostics and treatments

Sequenced Care – Providing diagnostics and treatments in a specific order

**Stepped Care** – Most effective, least resource intensive care is delivered first

Access to Care – Universal and equitable availability of care



# **Importance of Spectrum of Care**

**Increasing access to care** 



A lack of affordable, accessible care poses a tremendous challenge for veterinarians

#### Spectrum of Care STRATEGY

- Overcoming barriers to veterinary care
- Providing some type of care for patients
- Addressing problems of affordability
- Impacting issues of accessibility
- Serving socioeconomically diverse clientele



# Importance of Spectrum of Care

Managing the realities of practice



Many factors impact the reality of patient care

#### Spectrum of Care PRACTICE

- Establishing a relationship of trust
- Managing realistic expectations
- Contextualizing the care plan
- Emphasizing communication and documentation
- Gathering data and applying evidence

# AAVMC Spectrum of Care Initiative History & purpose



- Est. 2021 with support from The Stanton Foundation
- **Purpose:** Provide the infrastructure and support for an inclusive and collaborative approach to enhancing SOC pedagogy in veterinary education
- Structure: Task Force unites the workforce and education community



# AAVMC Spectrum of Care Initiative Goals



- ✓ Year 1: 2022-2023 Develop a competency-based SOC Education Model
- Year 2: 2023-2024 Establish implementation guidelines to support model integration
- Next Steps: 2024+ Pilot studies to evaluate & refine the model and guidelines

## **Building the SOC Education Model Evidence-based methods**

**Curricular elements identified through rigorous research** 

- Structured interviews / focus groups
- Findings from peer-reviewed research
- Recommendations from assessments guides and toolkits
- Methodologies across healthcare professions
- Iterative modified Delphi techniques
